Chair Lee Tischer led the flag salute.

Regular Meeting Agenda

Department of Natural Resources Timber Report

Padraic Callahan, St. Helens District Manager and Steve Ogden, Assistant Regional Manager, were in attendance to provide a timber report.

The Fir Real Sorts 2023 sale is conservatively expected to generate approximately \$1.191M for the county. There are two smaller lump sales for this year, as well. The Green Thomas sale is almost complete and should provide a total of approx. \$109,000. The Unibrow Sale has just become active and will provide approximately \$372,000 to the county. Total timber revenues for 2023 will be approximately \$1.672M for the county.

The 2024 Pollo Locho Sorts sale is estimated to be approximately \$1.5M and there is another small lump sale that might be available next year. The 2025 sale, Ten Fir Sorts, is located in Skamokawa and there is not yet an estimate on it. New roads will need to be constructed and some rock material will be reutilized from a nearby abandoned road.

The markets appear to be softening, but the hope is that there will not be a large fall in the market as housing is still in need. Some mills are operating on a daily quota as they are getting full, however, sales still appear to be holding. Staffing levels at the DNR are returning to normal.

The Board discussed options and issues with potentially contracting out the Shoreline Administrator duties versus a county employee performing the work. No decisions were made at this time, discussions will continue at a later date.

**A RESOLUTION AUTHORIZING A LOAN OF MONIES
FROM THE CONTINGENT LIABILITIES CUMULATIVE RESERVE
FUND TO THE CURRENT EXPENSE FUND**

WHEREAS, counties are authorized by law to make interfund loans; and

WHEREAS, the Wahkiakum County Treasurer has reported to the Board of County Commissioners that there now exists a need to make an interfund loan to the Current Expense Fund to meet the short-term cash flow obligations of the said Current Expense Fund;

NOW, THEREFORE, IT IS HEREBY RESOLVED AND ORDERED, as follows:

First: The Wahkiakum County Treasurer is authorized and directed to borrow \$750,000.00 from the Contingent Liabilities Cumulative Reserve Fund (116,000.00) and transfer said monies to the Current Expense Fund (001,000,000). This transaction shall be considered an interfund loan from the Contingent Liabilities Reserve Fund to the Current Expense Fund and is to be repaid from first available funds, together with interest at the rate of 4.65% per annum, not later than three (3) years from the date thereof.



Background Information	<p>The County Road Administration Board (CRAB) administers Standards of Good Practice for each of the 39 Counties in the State of Washington. The requirements are found in Washington Administrative Code at Chapter 136. While these standards are arguably a good thing, as they promote quality service to the taxpayers and positive relationships between government and the public, assuring we conform to these standards involves considerable effort by personnel of Public Works.</p> <p>CRAB annually requires a certification of conformance to their standards by response to a questionnaire. This response and certification must be returned by April 1 each year. In particular, the County Engineer and Chair of the Board must certify as to the accuracy of the conformance. Failure to do so would jeopardize motor vehicle fuel tax funds upon which the County depends, and limit our ability to apply for grant funds for road improvement projects.</p> <p>The Sheriff and County Auditor must also certify with respect to diversion of funds for traffic law enforcement, however Wahkiakum County is always in compliance because our population is below the 8,000 threshold.</p>

STATEMENT OF WORK

JAIL TRANSITION SERVICES

1. OVERVIEW.

Coordinate jail transition services with Great Rivers BH-ASO, local law enforcement, and jail personnel to expedite applications for Washington State Health Care Authority (HCA) benefits and facilitate coordination of care upon return to the community for individuals with mental illness and/or co-occurring disorders who are detained in city, county, and tribal jails in Wahkiakum County.

2. GOALS AND OBJECTIVES

- 2.1. Expedite HCA benefits for individuals with mental health disorders being released from local jails or juvenile detention facilities.
- 2.2. Safely transition individuals into the community outpatient behavioral health system from local jails or juvenile detention facilities.
- 2.3. Coordinate with outpatient providers for intake or continuity of service provision.

3. SERVICE REQUIREMENTS

The Contractor must:

- 3.1. Coordinate with local law enforcement, courts, and jail personnel to meet the needs of individuals detained in city, county, and tribal jails. Coordinate jail transition services with Great Rivers BH-ASO and treatment providers.
- 3.2. Implement policies and procedures that detail a referral process for individuals who are detained and have been diagnosed with a mental health disorder or are identified as needing behavioral health services.
- 3.3. Identify persons with mental health disorders who are incarcerated in city, county, and tribal jails or juvenile detention facilities, provide transition services to expedite their applications for HCA benefits, and facilitate coordination of care upon their return to the community.
- 3.4. Assist individuals with mental health disorders in completing and submitting applications for medical assistance to the HCA prior to release from jail.
- 3.5. Accept intake referrals for individuals who are not enrolled in community behavioral health services but who meet criteria for a priority population as defined in RCW 71.24. The Contractor shall conduct mental health intake assessments for these individuals and, when appropriate, provide transition services prior to their release from jail.
- 3.6. Initiate pre-release services, which shall include:

- 3.6.1. Mental health and substance use disorder (SUD) screening for individuals who display behavior consistent with a need for such screening who submit a Health Kite requesting services or who have been referred by jail staff, or officers of the court.
- 3.6.2. Mental health intake assessments for persons identified during the mental health screening as a member of the priority population as defined in Chapter 71.24 RCW.
- 3.6.3. Facilitation of expedited medical and financial eligibility determination with the goal of immediate access to benefits upon release from incarceration.
- 3.6.4. Other prudent pre-release (including pre-trial) case management and transition planning.
- 3.6.5. Direct mental health services to Individuals in jails with no behavioral health staff to provide services.
- 3.7. Provide post-release outreach to ensure follow-up for behavioral health and other services to stabilize individuals in the community.
- 3.8. With prior approval from Great Rivers BH-ASO, the Contractor may use Jail Coordination Services funds to facilitate any of the following activities, if the Contractor provided jail services through this Agreement:
 - 3.8.1. Development of individual alternative service plans (alternative to the jail) for submission to the courts.
 - 3.8.2. Inter-local agreements with juvenile detention facilities.
 - 3.8.3. Provision of up to a seven (7) day supply of medications, prescribed for the treatment of mental health symptoms, following the release from jail.
 - 3.8.4. Training for local law enforcement and jail services personnel.

4. PROGRAM REQUIREMENTS

- 4.1. The Contractor shall have one designated jail transition services employee.
- 4.2. **Service Area.** Services shall be available to Individuals that live in Wahkikaum County.
- 4.3. **Capacity.** The Contractor shall notify Great Rivers BH-ASO if they are reaching Enrollee capacity.
- 4.4. **Outcomes.**
 - 4.4.1. The Contractor will gather the following data:

- 4.4.1.1. Care Coordination. 100% of individuals that are open in behavioral health outpatient treatment receive care coordination.
- 4.4.1.2. Engagement in outpatient. Enroll 5 individuals into outpatient services post-release per fiscal year.
- 4.4.1.3. Intake. Complete intakes for the 5 individuals enrolled per fiscal year.
