Overview

Wahkiakum County Health and Human Services (HHS) is seeking bids for the first floor interior painting of the Annex building. The Annex is on adjoining property of the Hope Center located at 303 South 2nd Street.

Proposal Content and Submittal Requirements

1. Must be included in all bids:
 - a. All prep work including taping, sanding and removal of dining room wallpaper and related tasks.
 - b. Painting of all walls, ceiling, trim, cabinets, window frames and doors on the first floor only of the Annex. Include the following areas: living room, dining room, two offices (including closets), bathroom, hallway and front door entry way.
 - c. Disposal of all material that may be acquired.
2. Must include warranty information for all work and materials.
3. Must include pricing for all materials and labor.
4. Must include relevant taxes.
5. Include any additional relevant information regarding your bid and qualifications to meet this request.

Project

The Hope Center is a former church that was donated to HHS in October of 2017. In the near future, the HHS will be moving out of the Courthouse basement and into the Hope Center complex. Reflooring of both the Hope Center and Annex will soon begin. With the Annex being an older building, a fresh interior painting will be needed to make it a more professional environment for our financial employees'. We are looking to get this painting project completed before the reflooring project starts in mid-November.

The deadline for submission of sealed bid responses is Tuesday, October 18th, 2022 at 8:00 a.m. PST. Submit one sealed bid by mail to Wahkiakum County HHS, PO Box 696,



Cathlamet, WA 98612 or hand deliver to 64 Main Street, Cathlamet, WA at the Health Department. All responses must be addressed to the attention of Chris Bischoff, HHS Director.

The bids will be opened at the regular meeting of the commissioners on October 18th at 9:45 am.
